O P I N I O N      A N D      F I N D I N G S

On or about March 30, 2010, the Nebraska Public Service Commission (Commission) opened the above-mentioned docket, on its own motion, seeking to administer funding for public safety answering points for the implementation and provision of Enhanced Wireless 911 service pursuant to the permanent funding mechanism.<sup>1</sup>

On April 9, 2012, the City of Beatrice (Beatrice) filed its application for funding with the Commission pursuant to Neb. Admin. Code Title 291, Ch. 15 § 007.01. Beatrice serves Gage County.

Pending resolution of the issues currently being considered in Docket No. 911-019/PI-118<sup>2</sup>, Beatrice is eligible for interim funding in the amount of \$48,687.56 for the 2012-13 funding year. This amount reflects a deduction of pre-existing commitments in the amount of \$4,037.00. Beatrice has indicated that it anticipates using the funding provided for the following purposes: 911 maintenance agreements with Windstream and GeoComm, GIS data maintenance agreement, CAD software maintenance, and personnel necessary for the provision of enhanced wireless 911 service. The city plans to set aside none of its funding for future equipment and software upgrades and purchases. Although Beatrice indicated it would also use funding for radio equipment and digital media recorder maintenance, such uses are not eligible expenses.

Beatrice may not utilize wireless enhanced 911 funding for those purposes.

Based upon the above, the Commission finds that funding request for Beatrice in the amount of \$48,687.56 should be approved consistent with the allocation previously approved by the Commission in Application No. 911-019/PI-118<sup>3</sup>. Beatrice shall receive monthly payments in the amount of \$4,426.14 until issues currently pending in Application No. 911-019/PI-118 are resolved and the allocations are recalculated.

Once a final decision is made regarding modifications to the model and allocations for the 2012-13 funding year, the Commission will true-up funding amounts for PSAPs including but not limited to making any adjustments for pre-existing commitments that may have expired or otherwise changed, for any adjustments necessary based upon the audit for the 2010-11 funding year, deductions from funding for any late filed applications, and for any change in allocation resulting from the addition of the personnel cost module. All true-ups will be made retroactively to July 1, 2012.

Beatrice is required to submit documentation to justify expenditures, including an accounting of funds set aside for future equipment and software purchases, and update contact and other information no later than October 15 following the close of the funding year consistent with Neb. Admin. Code, Title 291, Ch. 15 § 008. If the Commission determines that any funds were not used appropriately, funding for the following funding year will be adjusted to recoup any necessary funds. All PSAPs are subject to audit.

#### O R D E R

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that the funding request for Beatrice is hereby approved as set forth herein.

IT IS FURTHER ORDERED that Beatrice must submit required documentation to justify all expenditures with approved funds no later than October 15 following the close of the funding year consistent with Neb. Admin. Code, Title 291, Ch. 15 § 008.
