BY THE COMMISSION:

On or about July 9, 2018, the Chase County ("Chase County") Public Safety Answering Point (PSAP) filed a request with the Public Service Commission ("Commission") to use enhanced wireless 911 setaside funds to purchase new call handling equipment, related software and connectivity services for the purpose of joining the regional network of PSAPs known as the South Central Region. The Commission approved this request by Order dated October 16, 2018.

On or about October 1, 2018, Chase County submitted a further funding request to use set-aside funds to pay for additional expenses incurred to join the South Central Region. In part, the additional funding request is for the purpose of paying Chase County's cost of joining the aggregated regional Geographic Information Systems (GIS) data hub previously approved for funding in the South Central Region (the "Data Hub"), plus three years of annual maintenance and quality control/quality assurance services. According to the documentation provided, Chase County's cost to join the Data Hub is a one-time charge of \$736.00 and an annual recurring maintenance cost of \$1,030.00.

Chase County also seeks permission to use set-aside funds to pay CenturyLink Business for additional connectivity charges not included in their earlier funding request. According to the documentation provided, the amount sought is a one-time charge of \$500.00 and recurring charges of \$678.00 per month for 36 months (\$8136.00 per year).

The Wireless Enhanced 911 Advisory Board considered this request at its October 29, 2018 meeting and recommended that the requested funding be approved.

OPINION AND FINDINGS

The Nebraska Public Service Commission ("Commission") adopted the permanent cost model to administer funding for public safety answering points for the implementation and provision of Enhanced Wireless 911 service under Docket No. 911-019/PI-118.3

Pursuant to Order adopted by the Commission on October 16, 2018, eligible costs incurred by PSAPs to join a region, such as equipment costs and the first year of multi-year maintenance, support or service agreements, may be fully paid from monies in the 911 Service System Fund, including set aside funds, without applying the wireless/wireline ratio.⁴ However, subsequent PSAP expenses, such as future years of multi-year maintenance, support or service agreements, and equipment costs incurred after joining a region remain subject to the wireless/wireline ratio.⁵

Based upon the request for funding, supporting documentation, and in consideration of the recommendation of the Advisory Board, the Commission is of the opinion and finds that the costs requested are eligible for funding as costs that have been incurred or will be incurred for the acquisition of new equipment and related maintenance costs and license fees, and/or the acquisition, installation, maintenance, and operation of telecommunications equipment and telecommunications service required for the provision of 911 service. In addition, the costs requested for the purchase and maintenance of software, including GIS data, are eligible for

funding.⁷ Moreover, all such costs requested are to be incurred by Chase County to join the South Central Region and are eligible to be paid from set aside funds, without applying the wireless/wireline ratio.

Pursuant to the permanent funding mechanism, PSAPs are permitted to set aside up to seventy-five percent (75%) of their annual funding allocation for the future purchase of equipment and software. Set aside funds may also be used to pay the first year of multi-year maintenance or support agreements. However, set aside funds may not be used to pay future years of multi-year maintenance or support agreements. Any such future costs must be paid from a PSAP's annually allocated funds or other sources. 10

Pursuant to the foregoing, the amount eligible for funding using set-aside funds with respect to the Data Hub is \$736.00 for one-time costs and \$1,030.00 for the first year of recurring maintenance, support or service costs. In addition, the amount eligible for funding using set-aside funds with respect to additional connectivity charges is \$500.00 for one-time costs and \$8,136.00 for the first year of recurring maintenance, support or service costs. Therefore, the total amount eligible for funding hereunder using set-aside funds is \$10,402.00.

Based upon the above, the Commission finds that use of setaside funding by Chase County should be approved as set forth herein in an amount up to \$10,402.00.

ORDER

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that funding for Chase County is hereby approved in the amount of up to \$10,402.00
