OPINION AND FINDINGS

On or about March 30, 2010, the Nebraska Public Service Commission (Commission) opened the above-mentioned docket, on its own motion, seeking to administer funding for public safety answering points for the implementation and provision of Enhanced Wireless 911 service pursuant to the permanent funding mechanism.¹

On April 13, 2012, Chase County filed its application for funding with the Commission pursuant to Neb. Admin. Code Title 291, Ch. 15 § 007.01. Chase County serves Chase County.

Pending resolution of the issues currently being considered in Docket No. 911-019/PI-118², Chase County is eligible for interim funding in the amount of \$9,982.03 for the 2012-13 funding year. This amount reflects a deduction for pre-existing commitments in the amount of \$16,235.92. Chase County has indicated that it anticipates using the funding provided for the following purposes: E911 telephone bills, training, and wireless headsets. The county plans to set aside 75% of its funding for future equipment and software upgrades and purchases.

Based upon the above, the Commission finds \$9,982.03 should be approved consistent with the allocation previously approved by the Commission in Application No. $911-019/PI-118^3$. Chase County shall receive monthly payments in the amount of \$907.46 until

All PSAPs are subject to audit.

ORDER
