## BY THE COMMISSION:

## OPINION AND FINDINGS

On or about March 30, 2010, the Nebraska Public Service Commission (Commission) opened the above-mentioned docket, on its own motion, seeking to administer funding for public safety answering points for the implementation and provision of Enhanced Wireless 911 service pursuant to the permanent funding mechanism.<sup>1</sup>

On April 11, 2012, Brown County filed its application for funding with the Commission pursuant to Neb. Admin. Code Title 291, Ch. 15 § 007.01. Brown County serves Brown County, Ainsworth, Long Pine and Johnstown.

Pending resolution of the issues currently being considered in Docket No. 911-019/PI-118², Brown County is eligible for interim funding in the amount of \$14,034.60 for the 2012-13 funding year. This amount reflects a deduction for pre-existing commitments in the amount of \$11,419.98. Brown County has indicated that it anticipates using the funding provided for the following purposes: support contracts for 911 hardware and software, GIS software support, GIS map data updates, training, future equipment and software purchases. The county plans to set aside up to 75% of its funding for future equipment and software upgrades and purchases.

Based upon the above, the Commission finds \$14,034.60 should be approved consistent with the allocation previously approved by

All true-ups will be made retroactively to July 1, 2012.

Brown County is required to submit documentation to justify expenditures, including an accounting of funds set aside for future equipment and software purchases, and update contact and other information no later than October 15 following the close of the funding year consistent with Neb. Admin. Code, Title 291, Ch. 15 § 008. If the Commission determines that any funds were not used appropriately, funding for the following funding year will be adjusted to recoup any necessary funds. All PSAPs are subject to audit.
