OPINION AND FINDINGS

On or about March 30, 2010, the Nebraska Public Service Commission (Commission) opened the above-mentioned docket, on its own motion, seeking to administer funding for public safety answering points for the implementation and provision of Enhanced Wireless 911 service pursuant to the permanent funding mechanism approved under Docket No. 911-019/PI-118.

On April 15, 2013, the City of Alliance (Alliance) filed its application for funding with the Commission pursuant to Docket No. 911-019/PI-118. Alliance serves city of Alliance, the village of Hemingford and the surrounding rural area in Box Butte County. Alliance is eligible for funding in the amount of up to \$54,313.90 for the 2013-14 funding year.

Alliance has indicated that it anticipates using the funding provided for costs related to upgrade of equipment and Intrado support, and plans to set aside 75% of its funding for future equipment and software upgrades and purchase. Although Alliance indicated that it intended to use enhanced wireless 911 funds for the purchase of furniture, it was advised that it would need to file a separate request for approval of that item.

Prior funding commitments in the amount of \$4,139 were previously approved and must be deducted from the allocation.

Based upon the above, the Commission finds that the funding request for Alliance in the amount of up to \$50,174.90, should be approved consistent with the allocation determined in Docket 911-019/PI-118 paid in monthly installments of \$4,561.35 over eleven months.

Pursuant to Docket 911-019/PI-118, Alliance is required to submit documentation to justify expenditures, including an

accounting of funds set aside for future equipment and software purchases, and update contact and other information no later than October 15 following the close of the funding year. If the Commission determines that any funds were not used appropriately, funding for the following funding year will be adjusted to recoup any necessary funds. All PSAPs are subject to audit.

ORDER

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that the funding request for Alliance is hereby approved as set forth herein in the amount of up to \$50,174.90.

IT IS FURTHER ORDERED that Alliance submit required documentation to justify all expenditures with approved funds no later than October 15 following the close of the funding year consistent with the terms of the order approving the permanent funding mechanism and process in Docket 911-019/PI-118 entered on February 23, 2010.
