BY THE COMMISSION:

On or about April 17, 2013, Sarpy County filed a request to use its set aside funding to upgrade its computer aided dispatch system in its 911 center. The total cost of the upgrade is \$1,076,586.00. Douglas County will be paying approximately 60.6% of the total costs. Sarpy County will be responsible for approximately \$316,516.28 of the total costs. Therefore, Sarpy County would propose using \$221,561.00 in wireless enhanced 911 funds toward the purchase based upon its wireless call ratio of 70%.

Therefore, Sarpy County is requesting approval to use its set aside funds in the amount of \$221,561.00, representing 60% of the total costs based upon wireless call volumes. The remaining costs will be paid by county general funds.

The Wireless Enhanced 911 Advisory Board considered the request at its April 22, 2013 meeting and recommended the request be approved.

O P I N I O N   A N D   F I N D I N G S

The Nebraska Public Service Commission (Commission) adopted the permanent cost model to administer funding for public safety answering points for the implementation and provision of Enhanced Wireless 911 service under Docket No. 911-019/PI-118.

Based upon the request, supporting documentation, and in consideration of the recommendation of the Advisory Board, the Commission is of the opinion and finds that a portion of the costs requested are eligible under Neb. Rev. Stat. § 86-465 as costs have been incurred or will be incurred for the purchase, installation, maintenance or operation of telecommunications equipment and telecommunications services required for the provision of enhanced wireless 911 service.

Pursuant to the permanent funding mechanism, PSAPs are permitted to retain up to seventy-five percent (75%) of the amount allocated to that PSAP for the future purchase of equipment and software.

Based upon the above, the Commission finds that Sarpy County's request should be approved in the amount of **\$221,561.00**.



