BY THE COMMISSION:

On or about October 6, 2014, Antelope County filed a request to use its wireless enhanced 911 set aside funds for the costs of an upgrade to 911 equipment and software in the amount of **\$157,461.93**. The total cost of the equipment and software contract is **\$157,461.93**. The PSAP's filed wireless call volume is **72%** of total call volume.

The Wireless Enhanced 911 Advisory Board considered the request at its October 20, 2014 meeting and recommended approval.

O P I N I O N A N D F I N D I N G S

The Nebraska Public Service Commission (Commission) adopted the permanent cost model to administer funding for public safety answering points for the implementation and provision of Enhanced Wireless 911 service under Docket No. 911-019/PI-118.

The Commission previously stated PSAPs may set aside up to seventy-five percent (75%) of their annual allocation for future equipment and software purchases and upgrades.¹ PSAPs may utilize these funds solely for upgrades and replacement of PSAP equipment and software, up to their wireless/wireline ratio. Prior to expending these funds, PSAPs must submit an application to the Commission for approval.
