O P I N I O N      A N D      F I N D I N G S

On or about March 30, 2010, the Nebraska Public Service Commission (Commission) opened the above-mentioned docket, on its own motion, seeking to administer funding for public safety answering points for the implementation and provision of Enhanced Wireless 911 service pursuant to the permanent funding mechanism.<sup>1</sup>

For the 2015-2016 funding year, Sprint was eligible to receive an allocated amount of up to \$177,101.00 and requested funding based on estimated costs in the amount of \$103,696.00. On June 16, 2015, the Commission entered an order approving annual funding for Sprint in the amount of up to \$103,696.00. The order indicated that Sprint should request increases to this amount should they find during the funding year that eligible costs were higher than its estimate, not to exceed the allocated amount.

Upon review, Sprint found that it incurred costs of \$124,190.94 during the 2015-2016 funding year. As a result, Sprint is requesting an additional **\$20,494.94** for the 2015-2016 funding year. The requested amount does not exceed the amount allocated to Sprint for the 2015-2016 funding year.

Based upon the above, the Commission finds that the funding request for Sprint should be adjusted in the amount of **\$20,494.94**.
