O P I N I O N A N D F I N D I N G S

On or about March 30, 2010, the Nebraska Public Service Commission (Commission) opened the above-captioned docket, on its own motion, seeking to administer funding for wireless service providers for the implementation and provision of Enhanced Wireless 911 service pursuant to the permanent funding mechanism approved under Docket No. 911-019/PI-118.

On March 12, 2012, Cricket Communications, Inc. (Cricket) filed an application for funding pursuant to Neb. Admin. Code Title 291, Ch. 15 § 007.01. Cricket serves multiple counties within Nebraska and states that the funds will be used for recurring monthly costs for TCS, administration, and LEC facilities charges.

Pending resolution of the issues currently being considered in Docket No. 911-019/PI-118¹, Cricket is eligible for interim funding up to \$58,937.16 paid in monthly installments of \$5,357.92 for funding year 2012-2013.

The Commission finds that the funding request for Cricket in the amount of \$58,937.16 should be approved, paid in monthly installments of \$5,357.92 until issues currently pending in Application No. 911-019/PI-118 are resolved and the allocations are recalculated.

Once a final decision is made regarding modifications to the model and allocations for the 2012-13 funding year, the Commission will true-up funding amounts for PSAPs including but not limited to making any adjustments for any adjustments necessary based upon the audit for the 2010-11 funding year,
