OPINION AND FINDINGS

On or about March 30, 2010, the Nebraska Public Service Commission (Commission) opened the above-mentioned docket, on its own motion, seeking to administer funding for public safety answering points for the implementation and provision of Enhanced Wireless 911 service pursuant to the permanent funding mechanism.¹

Pinpoint Wireless, d/b/a BLAZE Wireless (Pinpoint) requested interim funding in the amount of \$32,340.00. Because Pinpoint had not previously received funding, Commission staff examined the funding received by similarly situated wireless service providers and, considering Pinpoint's relatively low physical presence in a limited number of counties, estimated that Pinpoint would be eligible to receive only \$400.00. The Commission approved interim funding of \$400.00 on July 17, 2012. Interim payments were made with the understanding that any adjustments made as a result of issues being considered in Docket No. 911-019/PI-118² would be retroactive to July 1, 2012.

On September 18, 2012, the Commission entered an order in Docket No. 911-019/PI-118 resolving the outstanding issues resulting in adjustments to WSP funding.³ Based upon those

adjustments, the Commission finds that Pinpoint is eligible for an annual allocation of \$404.36. Therefore, Pinpoint is approved for a total permanent funding amount of \$404.36 for the 2012-2013 funding year. An adjustment for amounts already received was made in the amount of \$72.72.

Therefore, Pinpoint shall receive a total of \$331.64 to be paid in monthly installments in the amount of \$36.85 for the remaining nine (9) months of the 2012-2013 funding year.

Pinpoint is required to submit documentation to justify expenditures and update contact and other information no later than October 15 following the close of the funding year consistent with Neb. Admin. Code, Title 291, Ch. 15 § 008. If the Commission determines that any funds were not used appropriately, funding for the following funding year will be adjusted to recoup any necessary funds. All WSPs are subject to audit.

Any wireless service provider failing to file timely and accurate quarterly reports may be subject to delays or loss of funding in addition to any other administrative penalties.

ORDER

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that the funding for the Pinpoint is hereby adjusted as set forth herein.

IT IS FURTHER ORDERED that Pinpoint must submit required documentation to justify all expenditures with approved funds no later than October 15 following the close of the funding year consistent with Neb. Admin. Code, Title 291, Ch. 15 § 008.
