BY THE COMMISSION:

The Nebraska Public Service Commission opens the present docket on its own motion, seeking to investigate payments from the Enhanced Wireless 911 Fund for certain contracts for Geographical Information Systems (GIS) data and consulting services.

The Commission has received inquiries from public safety answering points (PSAPs) regarding whether funds from the Enhanced Wireless 911 Fund can be used to pay all costs of certain consulting contracts for GIS data services or whether the costs of such contracts are subject to the wireless/wireline allocation factor as outlined in Application No. 911-019/PI-118.

The Commission previously stated, "GIS data services are shared costs between wireless and wireline 911 and are therefore subject to the wireless/wireline ratio, unless a higher wireless call volume has been demonstrated by the PSAP." Therefore, current costs related to GIS data services are subject to the allocation and may not be fully funded by enhanced wireless 911 funds.

Based upon the inquiries received it appears that a certain vendor has attempted to draft a consulting contract to indicate GIS data services are only related to enhanced wireless 911 services in an effort to render the cost of the contract eligible for full funding from the Fund.

The Commission seeks information and comment regarding the contracts and services at issue in order to determine whether a

change in policy with respect to the funding of GIS data services is warranted. Specifically, the Commission seeks comment as to the specific services being provided under the consulting contracts and how the services provided under the consulting contracts at issue differ from general GIS data services.
