BY THE COMMISSION:

On May 6, 2014, the Nebraska Public Service Commission (Commission) entered an order on its own motion seeking to investigate and determine whether additional funds from the Enhanced Wireless 911 Fund should be made available to public safety answering points (PSAPs) for costs to implement text to 911 solutions.

On November 4, 2014, the Commission released Progression Order No. 3 in this docket, setting out the procedure to fund text to 911 outside the cost model for PSAPs ready to implement technology solutions on an interim basis. The staff proposal adopted set out the application process for PSAPs seeking interim funding for text to 911 solutions.

On or about February 6, 2018, the Furnas County PSAP ("Furnas") submitted an application in this docket requesting text to 911 funding for a Direct IP solution. The application listed \$2,397.62 in non-recurring costs and monthly recurring costs totaling \$4,500.00, representing recurring costs of \$125.00 per month for 36 months. Furnas serves Furnas and Gosper Counties.

The application was reviewed by technical subject matter experts, Mission Critical Partners ("MCP"), who advised the Commission that, based on MCP's review, the Furnas proposal was appropriate for funding.

The Enhanced Wireless 911 Advisory Board considered Furnas's funding request at its July 31, 2017 meeting and recommended that the Commission approve the funding request.

O P I N I O N S A N D F I N D I N G S

According to Neb. Rev. Stat. 86-465(2), costs incurred by public safety answering points for the provision of enhanced wireless 911 service may be eligible for payment from the Enhanced

Wireless 911 Fund, according to standards and criteria established by the Commission.

Pursuant to the staff proposal adopted in Progression Order No. 3 in this docket, the Commission may approve funding requests for text to 911 technology solutions costs such as text control center contracts, staff training, trunks necessary for additional text traffic, other costs related to the provision of text to 911 services not attributed more generally to 911 emergency response services. Progression Order No. 3 further specified that the Commission intended to limit approval of text to 911 related service contracts to no more than three years.

The Commission finds the application submitted by Furnas contains eligible costs under the interim text to 911 funding orders. PSAPs must submit invoices for payment by the Commission or submit invoices with evidence of payment for reimbursement to the PSAP from the Enhanced Wireless 911 Fund.

O R D E R

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that the text to 911 technology solution funding request submitted by Furnas County be, and is hereby, approved in an amount not to exceed \$2,397.62 non-recurring costs, plus a total of \$4,500.00 in monthly recurring costs over a 36-month period.

IT IS FURTHER ORDERED that Furnas County submit required documentation to justify all expenditures for payment or reimbursement from the Enhanced Wireless 911 Fund.
