BY THE COMMISSION:

By written request for funding received July 17, 2002, Dodge County seeks funding from the Enhanced Wireless 911 Fund for expenses of implementing and providing enhanced wireless 911 service. Dodge County has one public safety answering point (PSAP), which will provide enhanced wireless 911 service throughout Dodge County. The local exchange carrier serving Dodge County's PSAP is Qwest Corporation (Qwest). In Application No. PSAP-006, Dodge County was approved for funding for service from four wireless carriers. By this application, Dodge County seeks to add service from an additional wireless carrier, Nextel.

Dodge County seeks initial costs of \$2,579.80 and recurring costs of \$457.10 per month to implement and provide enhanced wireless 911 service for the additional above-listed wireless carrier. Initial costs are for database upgrades, trunking infrastructure and purchase, installation, and testing of circuits for enhanced wireless 911. Recurring costs are monthly fees for database management and for operation and maintenance of trunks and circuits.

Dodge County entered into a service agreement with Qwest for enhanced wireless 911 equipment and services. In the agreement, Dodge County authorized the Nebraska Public Service Commission to remit all payments for enhanced wireless 911 service to Qwest.

O P I N I O N A N D F I N D I N G S

This request for funding is being processed pursuant to Neb. Rev. Stat. §§ 86-2201 to 86-2214. (2001 Supp.), 291 Neb. Admin. Code, Chapter 1, Section 5, and Progression Order No. 4 in Commission Docket No. 911-001, entered April 23, 2002.

Costs requested are eligible under Neb. Rev. Stat. § 86-2210 (2001 Supp.) All costs have been incurred or will be incurred for the purchase, installation, maintenance and

operation of telecommunications equipment and telecommunications services required for the provision of enhanced wireless 911 service.

Because Dodge County authorized Qwest to receive all payments on its behalf for wireless enhanced 911, the Commission finds that payment for costs requested in this application should be made to Qwest upon invoice. Only invoices that comport with the approved costs in this order will be paid. Recurring costs requested for partial months must be pro rated.

Furthermore, all costs of Nebraska Universal Service Fund surcharges arising from this application should be paid, and any legitimate government-imposed taxes or surcharges assessed on enhanced wireless 911 charges should be paid. Dodge County should true-up its subscriber counts on a quarterly basis and the Commission should pay resulting non-recurring and recurring charges.

Based upon the request for funding and supporting documentation, the Commission is of the opinion and finds that the request for funding should be granted.

O R D E R

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Dodge County's request for funding shall be granted.

IT IS FURTHER ORDERED that upon invoice from Qwest, the Commission shall remit to Qwest amounts that comport with this order.

IT IS FURTHER ORDERED that any government imposed-taxes or surcharges assessed on enhanced wireless 911 charges shall be paid.

IT IS FURTHER ORDERED Dodge County shall be paid for non-recurring and recurring charges resulting from increased subscriber counts, and that Dodge County shall true-up its subscriber counts on a quarterly basis.
