BY THE COMMISSION:

By written request for funding received April 12, 2002, Chase County seeks funding from the Enhanced Wireless 911 Fund for expenses of implementing and providing enhanced wireless 911 service. Chase County has one public safety answering point (PSAP), which will provide enhanced wireless 911 service throughout Chase County. The local exchange carrier serving Chase County's PSAP is Qwest Corporation (Qwest). Chase County's PSAP is served by the following wireless carriers: Western Wireless and ALLTEL Cellular.

Chase County entered into a service agreement with Qwest for enhanced wireless 911 equipment and services. A copy of the agreement is attached to the request for funding. In the agreement, Chase County authorized the Nebraska Public Service Commission to remit all payments for enhanced wireless 911 service to Qwest.

Chase County seeks initial costs of \$7,679.90 and recurring costs of \$763.10 per month to implement and provide enhanced wireless 911 service for each of the above-listed wireless carriers. Initial costs are for database upgrades, trunking infrastructure and purchase, installation and testing of circuits for enhanced wireless 911. Recurring costs are monthly fees for database management and for operation and maintenance of trunks and circuits.

O P I N I O N       A N D       F I N D I N G S

This request for funding is being processed pursuant to Neb. Rev. Stat. §§ 86-2201 to 86-2214. (2001 Supp.), 291 Neb. Admin. Code, Chapter 1, Section 5, and Progression Order No. 3 in Commission Docket No. 911-001, entered January 29, 2002.

Costs requested are eligible under Neb. Rev. Stat. § 86-2210 (2001 Supp.) All costs have been incurred or will be incurred for the purchase, installation, maintenance and operation of telecommunications equipment and telecommunications

services required for the provision of enhanced wireless 911 service.

Chase County has submitted a PSAP registration in compliance with Progression Order No. 3 in Commission Docket No. 911-001.

Because Chase County authorized Qwest to receive all payments on its behalf for wireless enhanced 911, the Commission finds that payment should be made to Qwest upon invoice. Only invoices that comport with the approved costs in this order will be paid. Recurring costs requested for partial months must be pro rated.

Based upon the request for funding and supporting documentation, the Commission is of the opinion and finds that the request for funding should be granted.

O R D E R

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Chase County's request for funding shall be granted.

IT IS FURTHER ORDERED that upon invoice from Qwest, the Commission shall remit to Qwest amounts that comport with this order.
