BY THE COMMISSION:

By written request for funding received September 23, 2002, Dawson County PSAP, Lexington, seeks funding from the Enhanced Wireless 911 Fund for expenses of implementing and providing enhanced wireless 911 service. Dawson County has one public safety answering point (PSAP), which will provide enhanced wireless 911 service throughout Dawson County. The serving Dawson County's PSAP exchange carrier is Owest Dawson County's PSAP is served by the Corporation (Owest). following wireless carriers: ALLTEL, Nebraska Wireless and Western Wireless.

Dawson County entered into a service agreement with Qwest for enhanced wireless 911 equipment and services. A copy of the agreement is attached to the request for funding. In the agreement, Dawson County authorized the Nebraska Public Service Commission to remit all payments for enhanced wireless 911 service to Qwest.

Dawson County seeks initial costs of \$20,519.60 and recurring costs of \$2,440.40 per month to implement and provide enhanced wireless 911 service for each of the above-listed wireless carriers. Initial costs are for database upgrades, trunking infrastructure and purchase, installation, and testing of circuits for enhanced wireless 911. Recurring costs are monthly fees for database management and for operation and maintenance of trunks and circuits.

OPINION AND FINDINGS

This request for funding is being processed pursuant to $\underline{\text{Neb}}$. $\underline{\text{Rev}}$. $\underline{\text{Stat}}$. §§ 86-2201 to 86-2214. (2001 Supp.), 291 Neb. Admin. Code, Chapter 1, Section 5, and Progression Order No. 5 in Commission Docket No. 911-001, entered July 16, 2002.

Costs requested are eligible under $\underline{\text{Neb}}$. $\underline{\text{Rev}}$. $\underline{\text{Stat}}$. § 86-2210 (2001 Supp.). All costs have been incurred or will be incurred for the purchase, installation, maintenance and

operation of telecommunications equipment and telecommunications services required for the provision of enhanced wireless 911 service.

Dawson County has submitted a PSAP registration in compliance with Commission Docket No. 911-001.

Because Dawson County authorized Qwest to receive all payments on its behalf for wireless enhanced 911, the Commission finds that payment should be made to Qwest upon invoice. Only invoices that comport with the approved costs in this order will be paid. Recurring costs requested for partial months must be pro rated.

Based upon the request for funding and supporting documentation, the Commission is of the opinion and finds that the request for funding should be granted. All costs of Nebraska Universal Service Fund (NUSF) surcharges and any legitimate government-imposed taxes or surcharges assessed on enhanced wireless 911 charges should also be paid. The Commission further finds that Dawson County should true-up its subscriber counts on a quarterly basis and that the Commission should adjust payments for non-recurring and recurring charges accordingly.

ORDER

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Dawson County's request for funding shall be granted.

IT IS FURTHER ORDERED that upon invoice from Qwest, the Commission shall remit to Qwest amounts that comport with this order.

IT IS FURTHER ORDERED that any government-imposed taxes or surcharges assessed on enhanced wireless 911 charges shall be paid.

IT IS FURTHER ORDERED that Dawson County provide to the Commission, updated subscriber counts on a quarterly basis, and that payments to Dawson County shall be adjusted accordingly.
