## OPINION AND FINDINGS

Upon further review and in consideration of additional input from the parties in written comments filed June 13, 2001, and orally at the prehearing conference in Application No. C-2537, the Commission is of the opinion and finds that the procedural schedule issued on June 19, 2001, should be modified. In an effort to avoid unnecessary confusion, the timeline as modified will be set forth in its entirety below:

Furthermore, in an effort to create a framework for presentation of witnesses at the public hearings, the Commission will allow 20 minutes per side for opening, 30 minutes per side per witness (on average), and 60 minutes for cross examination per side. For oral arguments, each side will be allowed up to 20 minutes per issue. While the Commission will be flexible in the application of time limits, any substantial deviations will require prior Commission approval.

Finally, to the extent parties desire to file post-hearing briefs or briefs following oral arguments, such briefs shall be filed within 10 days after the conclusion of the respective hearing or oral argument. Parties are requested to file an original plus six copies with the Commission as well as an electronic copy in Wordperfect 5.0 or later.

## ORDER

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that all parties participating in Application Nos. C-1830; C-2537; and C-2516/PI-49 shall comply with the modified schedule outlined above for proceedings in these applications.
