BY THE HEARING OFFICER:

On December 20, 2018, the Nebraska Public Service Commission ("Commission") received a Formal Complaint from Platte Valley Financial Services Companies, Inc., and Affiliates (Platte Valley) of Scottsbluff, Nebraska, against CenturyLink Communications LLC (CenturyLink) of Monroe, Louisiana, alleging inadequacy of service and inaccurate billing. The Complaint was amended on February 6, 2019. An Answer and a Motion to Dismiss were filed on February 15, 2019. Platte Valley filed an Objection to the Motion to Dismiss and Request for Oral Argument on February 28, 2019. On May 7, 2019, the Commission overruled CenturyLink's Motion to Dismiss.
