By Application filed April 5, 2019, Mary Ann Ruzicka, Ronald Nuss, and Kristin Jerred, Aurora, each seek authority to receive advanced telecommunications service from the Stockham exchange of the Hamilton Telephone Company. Notice of the Application appeared in The Daily Record, Omaha, Nebraska, on April 16, 2019.

Pursuant to Neb. Rev. Stat. § 86-135, a hearing is required when the telecommunications companies involved do not consent to the application. On May 16, 2019, Windstream Communications filed with the Commission a letter stating that it did not consent to the boundary change requested in this application.

On May 22, 2019, Applicant Kristin Jerred notified the Commission that she wished to withdraw her portion of the application due to having moved away from the listed address. Consequently, I therefore will allow Applicant Kristin Jerred to withdraw from this application. Applicants Mary Ann Ruzicka and Ronald Nuss remain as applicants to this docket, and will be allowed to proceed with their application.

Furthermore, as Windstream Communications does not consent to the requested boundary change, I hereby schedule the hearing in the above-captioned application to be held on **July 9, 2019, at 11:00 a.m. CDT** at the Sutton City Hall, 107 W Grove Street, Sutton, NE 68979.
