BY THE COMMISSION:

By Application filed December 13, 2018 Kevin Rainforth, Doniphan, Nebraska, sought authority to receive advanced telecommunications service from the Doniphan Exchange of Hamilton Telephone Company (Hamilton) rather than from the Hansen Exchange served by Windstream Nebraska, Inc. (Windstream). Notice of the Application appeared in The Daily Record, Omaha, Nebraska, on December 17, 2018.

OPINION AND FINDINGS

By Application filed November 30, 2018, Eugene Griess of Sutton, Nebraska, sought authority to receive advanced telecommunications service from the Aurora exchange of Hamilton Telephone Company (Hamilton) rather than from the Sutton Exchange served by Windstream Nebraska, Inc. (Windstream). Notice of the Application appeared in Daily Record, Omaha, Nebraska, on December 17, 2018.

On February 25, 2019, Windstream filed a letter stating that it did not consent to the boundary change. Pursuant to Neb. Rev. Stat. § 86-135, the Commission held a hearing on April 24, 2019 at the Doniphan Event Center, 103 W Pine Street, Doniphan, Nebraska 68832. The application, response, publication, and hearing notice were made part of the record by the Commission. Mary Jacobson appeared on behalf of Windstream. Pat Shaw testified on behalf of Hamilton, but was not represented by counsel. Shana Knutson appeared on behalf of Commission staff.

On May 21, 2019, the Commission entered an order granting the application. On May 29, 2019, Windstream filed a Motion for Rehearing. Windstream stated in its motion that it seeks rehearing based on the grounds of substantive errors made in consideration of the applications.
