BY THE COMMISSION:

By application filed June 18 2019, United Telephone Company of the West d/b/a CenturyLink ("CenturyLink"), Denver, Colorado seeks approval of a VoIP Provider Amendment to the Interconnection Agreement with Teliax, Inc. ("Teliax") of Denver, Colorado. The underlying agreement was approved by the Commission in Application No. C-5059. Notice of the application was published in The Daily Record, Omaha, Nebraska, on June 25, 2019. No protests were filed; therefore, this application is processed pursuant to the Commission's Rule of Modified Procedure.

Pursuant to Section 252(a) of the Telecommunications Act of 1996 (the Act), CenturyLink and Teliax entered into a VoIP Provider Amendment to their Interconnection Agreement arrived at through voluntary negotiations. An executed copy of this amendment is contained within the application.

Neither the amendment nor any portion thereof discriminates against any telecommunications carrier. Furthermore, the implementation of the amendment is consistent with the public interest, convenience and necessity.

Section 252(e) of the Act requires this Commission to review interconnection agreements adopted by negotiation or arbitration to ensure they comply with Sections 251 and 252(d) of the Act, as well as all applicable state laws. Using those standards, the amendment should be approved.
