BY THE COMMISSION:

By Application filed January 9, 2020, United Telephone Company of the West d/b/a CenturyLink QC (CenturyLink QC), of Denver, Colorado, seeks approval of a Transport Rate Amendment to the Interconnection Agreement with CSC Wireless, LLC d/b/a Altice Mobile (Altice Mobile), of Plano, Texas. Notice of the application was published in The Daily Record, Omaha, Nebraska, on January 14, 2020. No protests were filed; therefore, this application is processed pursuant to the Commission's Rule of Modified Procedure.

Pursuant to the federal Telecommunications Act of 1996 ("the Act"), specifically 47 U.S.C. § 252(a), CenturyLink QC and Altice Mobile entered into a Transport Rate Amendment to their Interconnection Agreement arrived at through voluntary negotiations. An executed copy of this agreement is contained within the application.

Neither the agreement nor any portion thereof discriminates against any telecommunications carrier. Furthermore, the implementation of the agreement is consistent with the public interest, convenience and necessity.

Section 252(e) of the Act requires this Commission to review Interconnection Agreements adopted by negotiation or arbitration to ensure they comply with Sections 251 and 252(d) of the Act, as well as all applicable state laws. Using those standards, the Commission finds that this Interconnection Agreement should be approved.

O R D E R

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that the Transport Rate Amendment to the Interconnection Agreement between CenturyLink QC and Altice Mobile shall be, and is hereby, approved.

IT IS FURTHER ORDERED that the executed Transport Rate Agreement to the Interconnection Agreement filed herein be, and it is hereby, made the official copy on file with the Nebraska Public Service Commission.
