BY THE COMMISSION:

By application filed April 8, 2020, Qwest Corporation d/b/a CenturyLink QC, of Denver, Colorado, seeks approval of a Resale Forbearance Amendment to the Interconnection Agreement with Teleport Communications America, LLC, of Bedminster, New Jersey, for the State of Nebraska. Notice of the application was published in The Daily Record, Omaha, Nebraska, on April 13, 2020. No protests were filed; therefore, this application is processed pursuant to the Commission's Rule of Modified Procedure.

Pursuant to the federal Telecommunications Act of 1996 ("the Act"), specifically 47 U.S.C. § 252(a), Qwest Corporation dba CenturyLink QC and Teleport Communications America, LLC, entered into an amendment to their interconnection agreement arrived at through voluntary negotiations. An executed copy of this agreement is contained within the application.

Neither the agreement nor any portion thereof discriminates against any telecommunications carrier. Furthermore, the implementation of the agreement is consistent with the public interest, convenience and necessity.

Section 252(e) of the Act requires this Commission to review Interconnection Agreements adopted by negotiation or arbitration to ensure they comply with Sections 251 and 252(d) of the Act, as well as all applicable state laws. Using those standards, the Commission finds that this amendment should be approved.
