By application filed April 9, 2020, United Telephone Company of the West dba CenturyLink, Denver, Colorado, seeking approval of a Resale Forbearance Amendment to the Interconnection Agreement with BullsEye Telecom, Inc., Southfield, Michigan, for the State of Nebraska. Notice of the application was published in The Daily Record, Omaha, Nebraska, on April 15, 2020. No protests were filed; therefore, this application is processed pursuant to the Commission's Rule of Modified Procedure.

Pursuant to the federal Telecommunications Act of 1996 ("the Act"), specifically 47 U.S.C. § 252(a), United Telephone Company of the West dba CenturyLink and BullsEye Telecom Inc., entered into a Resale Forbearance Amendment to their interconnection agreement arrived at through voluntary negotiations. An executed copy of this agreement is contained within the application.

Neither the amendment nor any portion thereof discriminates against any telecommunications carrier. Furthermore, the implementation of the amendment is consistent with the public interest, convenience and necessity.

Using those standards, the Commission finds that this amendment should be approved.
