O P I N I O N A N D F I N D I N G S

On March 21, 2019, the Nebraska Universal Service Fund ("NUSF") Department of the Nebraska Public Service Commission ("the Department") filed a Complaint against LCR Telecommunications, Inc. (hereinafter "Respondent"), seeking to fine Respondent on the grounds that it failed to file required remittance worksheets and/or remittance payments as required by Nebraska statutes and regulations. See Neb. Rev. Stat. §§ 86-316 - 329 and 291 Neb. Admin. Code, Chapter 10. Specifically, the Complaint alleged that Respondent did not timely file its remittance worksheet for the remittance periods consisting of 2nd Quarter 2018, 3rd Quarter 2018, and 4th Quarter 2018.

Since the Complaint in this matter was entered, the Respondent has entered into a stipulated agreement with the Department resolving the allegations contained in the Complaint. Pursuant to this agreement, Respondent has paid a fine to the Department and has agreed to timely file its remittance payments and worksheets henceforth. Also pursuant to the agreement, the Department and Respondent have jointly requested the Commission to enter an order in this docket dismissing the Complaint and releasing Respondent from further compliance obligations regarding the NUSF remittance payment and worksheet for the remittance periods of 2nd Quarter 2018, 3rd Quarter 2018, and 4th Quarter 2018, as well as one remittance period not named in the Complaint and consisting of 1st Quarter 2020.
