OPINION AND FINDINGS

On February 5, 2019, the Nebraska Public Service Commission (Commission) initiated this docket on its own motion to investigate service quality issues in the Oshkosh, Lewellen, and Chappell Telephone Exchanges served by United Telephone Company of the West d/b/a CenturyLink Communications ("CenturyLink").

On April 8, 2019, the Commission held a public hearing in Oshkosh, Nebraska. At that hearing, the Commission received public testimony and exhibits from twelve CenturyLink subscribers explaining the various issues they have had with CenturyLink service. CenturyLink also provided testimony in response. CenturyLink's witness committed to working with the Commission and the subscribers to resolve the service quality issues. CenturyLink provided the Commission with updates and stated its belief that it has resolved the service quality issues with the subscribers in that area.

At this time, the Commission finds that a hearing should be again scheduled in Oshkosh to determine whether those issues have been resolved and whether there are any other service quality issues consumers in that community are experiencing. Accordingly, we find that a hearing will be held on **August 19**, **2020** at 12:30 p.m., at the Oshkosh Auditorium, 600 W. 2nd Street, Oshkosh, Nebraska 69154.
