## BY THE COMMISSION:

By application filed April 15, 2020, Citizens Telecommunications Company of Nebraska dba Frontier Communications of Nebraska (Frontier), of Mound, Minnesota, is seeking approval of a Local Resale Interconnection Agreement with BullsEye Telecom, Inc. (BullsEye), of Southfield, Michigan. Notice of the application was published in <a href="The Daily Record">The Daily Record</a>, Omaha, Nebraska, on April 17, 2020. No protests were filed; therefore, this application is processed pursuant to the Commission's Rule of Modified Procedure.

Pursuant to the federal Telecommunications Act of 1996 ("the Act"), specifically 47 U.S.C. § 252(a), Frontier and BullsEye entered into a Local Resale Interconnection Agreement arrived at through voluntary negotiations. An executed copy of this agreement is contained within the application.

Neither the agreement nor any portion thereof discriminates against any telecommunications carrier. Furthermore, the implementation of the agreement is consistent with the public interest, convenience and necessity.

Section 252(e) of the Act requires this Commission to review Interconnection Agreements adopted by negotiation or arbitration to ensure they comply with Sections 251 and 252(d) of the Act, as well as all applicable state laws. Using those standards, the Commission finds that this Local Resale Interconnection Agreement should be approved.
