BY THE COMMISSION:

By application filed May 27, 2020, United Telephone Company of the West dba CenturyLink QC (CenturyLink QC), of Denver, Colorado, seeks approval of a Resale Forbearance Amendment to its Interconnection Agreement with Spectrotel, Inc. (Spectrotel), of Neptune, New Jersey. The underlying Interconnection Agreement was previously approved by the Commission in Application No. C-4554. Notice of the application was published in The Daily Record, Omaha, Nebraska, on June 2, 2020. No protests were filed; therefore, this application is processed pursuant to the Commission's Rule of Modified Procedure.

Pursuant to the federal Telecommunications Act of 1996 ("the Act"), specifically 47 U.S.C. § 252(a), CenturyLink QC and Spectrotel, entered into a Resale Forbearance Amendment to their Interconnection Agreement arrived at through voluntary negotiations. An executed copy of this amendment is contained within the application.

Neither the amendment nor any portion thereof discriminates against any telecommunications carrier. Furthermore, the implementation of the amendment is consistent with the public interest, convenience and necessity.

Section 252(e) of the Act requires this Commission to review Interconnection Agreements adopted by negotiation or arbitration to ensure they comply with Sections 251 and 252(d) of the Act, as well as all applicable state laws. Using those standards, the Commission finds that this amendment should be approved.
