This matter arises from a Complaint filed with the Nebraska Public Service Commission (Commission) on May 5, 2020. In that Complaint, Mr. Cullen Robbins, Director of the Nebraska Universal Service Fund Department of the Nebraska Public Service Commission (Complainant) alleged that Norstan Network Services, Inc., of Tampa, FL, (Respondent) failed to timely file its remittance payments and/or worksheets with the Commission for the remittance periods of December 2019 and March 2020. The Complainant further sought penalties of up to ten thousand dollars (\$10,000) per violation, per day, against the Respondent.

Pursuant to 291 Neb. Admin. Code § 1-004.02B1, the Respondent was required to file an Answer to this Complaint within twenty (20) days. No such Answer was filed. The Respondent has indicated to Commission staff that it is not willing to settle this matter under the Commission's late remittance fining policy. Therefore, I find that this matter should be set for hearing.

This matter is therefore scheduled to be heard on **Tuesday, September 1, 2020, at 11:00 a.m. CDT** at the Commission Hearing Room, 300 The Atrium, 1200 N Street, Lincoln, Nebraska. Webconference access will be made available to the parties.


O R D E R
