By Application filed July 8, 2020, Qwest Corporation dba CenturyLink QC, Denver, Colorado, seeks approval of a Resale Forbearance Amendment to the Interconnection Agreement with Pinpoint Communications, Inc., of Cambridge, Nebraska. Notice of the application was published in <a href="The Daily Record">The Daily Record</a>, Omaha, Nebraska, on July 13, 2020. No protests were filed; therefore, this application is processed pursuant to the Commission's Rule of Modified Procedure.

Pursuant to the federal Telecommunications Act of 1996 ("the Act"), specifically 47 U.S.C. § 252(a), Qwest Corporation dba CenturyLink QC and Pinpoint Communications, Inc., entered into a Resale Forbearance Amendment arrived at through voluntary negotiations.
