### BY THE COMMISSION:

On July 6, 2020 an Application was filed by J.H. Kime & Sons Cattle Co., of Wood Lake, Nebraska seeking a boundary change to receive advanced telecommunications capability service from the Valentine Exchange of CenturyLink Communications, LLC ("CenturyLink"), in lieu of their current telephone service from Great Plains Communications. Notice of the application was published in The Daily Record, Omaha, Nebraska, on July 14, 2020. No protests were filed; therefore, this docket was handled pursuant to the Commission's Rules of Modified Procedure.

### O P I N I O N    A N D    F I N D I N G S

CenturyLink and Great Plains Communications are local exchange carriers holding certificates of public convenience and necessity to provide local exchange service in their respective territories. J.H. Kime & Sons Cattle Co. resides within the boundary of Great Plains' Exchange, and has requested a boundary change so that it may receive telephone service from the Valentine Exchange of CenturyLink. Great Plains Communications has notified the Commission that it does not oppose the proposed boundary change. CenturyLink has also notified the Commission that it is willing to make the boundary change and provide service to the Applicant.

Changes of a local exchange territory are governed by *Neb. Rev. Stat.* §§ 86-135 to 86-138. Section 86-135 states that only upon non-consent of all telephone carriers involved shall the Commission hold a public hearing in the application. With no protest filed by any party and with each of the affected local exchange carriers consenting to the boundary change, the Commission processes this application administratively and without a public hearing.

The Commission staff has modified the Great Plains Communications and CenturyLink local exchange maps to show the

boundary change to the Valentine Exchange. Copies of the exchange maps with the proposed revisions are attached as Attachment "A" to this Order and hereby incorporated for reference. If either company has objections or changes to the proposed boundary map, it has until September 25, 2020, to contact the Commission with said objections or changes. If the Commission receives no objections or changes from Great Plains Communications or CenturyLink by close of business on September 25, 2020 the boundary maps shall be modified as proposed in Attachment "A".

The Commission finds that, in light of the consent between the parties involved, the application is in the public interest and should be granted. It is the expectation of the Commission that the two carriers involved in the boundary change shall collaborate in good faith to ensure that the transition of the customer's service from one carrier to the other shall be as seamless as possible.

### O R D E R





IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Application No. C-5148 be, and it is hereby, granted.

IT IS FURTHER ORDERED that on or before September 25, 2020 the parties to this docket shall contact the Commission with any changes or concerns regarding the boundary as proposed in Attachment "A" to this order. If no objection is received from Great Plains Communications or CenturyLink, the boundary as shown in Attachment "A" to this Order, shall be the official boundary of the two telecommunication companies.
