BY THE COMMISSION:

By Application filed July 22, 2020, Qwest Corporation dba CenturyLink QC (CenturyLink), of Denver, Colorado, seeks approval of a Resale Forbearance Amendment to the Interconnection Agreement with FiberComm, LLC (FiberComm), of Sioux City, Iowa. Notice of the application was published in The Daily Record, Omaha, Nebraska, on July 27, 2020. No protests were filed; therefore, this application is processed pursuant to the Commission's Rule of Modified Procedure.

Pursuant to the federal Telecommunications Act of 1996 ("the Act"), specifically 47 U.S.C. § 252(a), Qwest Corporation dba CenturyLink and FiberComm entered into a Resale Forbearance Amendment arrived at through voluntary negotiations. An executed copy of this amendment is contained within the application.

Neither the amendment nor any portion thereof discriminates against any telecommunications carrier. Furthermore, the implementation of the amendment is consistent with the public interest, convenience and necessity.

Section 252(e) of the Act requires this Commission to review Interconnection Agreements adopted by negotiation or arbitration to ensure they comply with Sections 251 and 252(d) of the Act, as well as all applicable state laws. Using those standards, the Commission finds that this amendment should be approved.

## O R D E R

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that the Resale Forbearance Amendment between Qwest Corporation dba CenturyLink QC and FiberComm, LLC, shall be, and is hereby, approved.
