BY THE COMMISSION:

By Application filed July 24, 2020, New Cingular Wireless PCS, LLC, of Bedminster, New Jersey, is seeking approval of a Traffic Exchange Agreement with Southeast Nebraska Communications, Inc., of Falls City, Nebraska. Notice of the application was published in The Daily Record, Omaha, Nebraska, on August 6, 2020. No protests were filed; therefore, this application is processed pursuant to the Commission's Rule of Modified Procedure.

Pursuant to the federal Telecommunications Act of 1996 ("the Act"), specifically 47 U.S.C. § 252(a), New Cingular Wireless PCS, LLC and Southeast Nebraska Communications, Inc., entered into a Traffic Exchange Agreement arrived at through voluntary negotiations. An executed copy of this agreement is contained within the application.

Neither the agreement nor any portion thereof discriminates against any telecommunications carrier. Furthermore, the implementation of the agreement is consistent with the public interest, convenience and necessity.

Section 252(e) of the Act requires this Commission to review Interconnection Agreements adopted by negotiation or arbitration to ensure they comply with Sections 251 and 252(d) of the Act, as well as all applicable state laws. Using those standards, the Commission finds that this Interconnection Agreement should be approved.

O R D E R

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that the Interconnection Agreement between New Cingular Wireless PCS, LLC and Southeast Nebraska Communications, Inc., shall be, and is hereby, approved.
