BY THE COMMISSION:

By application filed September 14, 2020, Geneva Broadband, LLC ("Geneva") of Geneva, Nebraska, and Glenwood Telecommunications, Inc. ("Glenwood") of Blue Hill, Nebraska (collectively "Applicants") request to transfer control of Geneva's operations to Glenwood. Applicants also seek to cancel Geneva's certificate of authority to operate as a competitive local exchange carrier of telecommunications services and to cancel its tariffs in the State of Nebraska. Notice of the application was published in The Daily Record, Omaha, Nebraska, on September 16, 2020. No protests or interventions were filed; therefore, this application is processed pursuant to the Commission's Rule of Modified Procedure.

O P I N I O N A N D F I N D I N G S

By virtue of the authority granted by the Commission in Docket No. C-3872, Geneva was given the ability to offer competitive local exchange services within the State of Nebraska. Geneva now seeks cancellation of its Certificate of Public Convenience and Necessity and Tariff within the State of Nebraska. The Certificate is no longer necessary because it has transferred all of its assets and customers to Glenwood, an interexchange and competitive local exchange carrier granted authority to operate in Nebraska pursuant to Commission Dockets Nos. C-1926 and C-3853. Pursuant to this transaction, Geneva no longer serves customers in Nebraska. Applicants state that the transaction of Geneva's business to Glenwood is in the public interest, and state that it was transparent to customers and did not affect their rates, terms, or conditions of service.

Upon consideration of the request and being fully advised in the premises, the Commission finds the request to be reasonable. The Commission finds that the transfer of control should be approved and, finds that the Certificate of Public Convenience and Necessity issued to Geneva Broadband, LLC to offer telecommunications services should be cancelled, along with all applicable tariffs.

O R D E R





IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Application No. C-5169 is hereby granted, and the Certificate of Public Convenience and Necessity granted to Geneva Broadband, LLC to offer telecommunications service in the State of Nebraska and all applicable tariffs are cancelled.


IT IS FURTHER ORDERED that the transfer of control described in Application No. C-5169 should be approved.
