BY THE COMMISSION:

By Application filed March 16, 2021, Sprint Communications Company, L.P. ("Sprint" or "Applicant"), of Bellevue, Washington, seeks to withdraw its authority to offer interexchange telecommunications services and to cancel its tariffs in the State of Nebraska. Notice of the application was published in The Daily Record, Omaha, Nebraska, on March 23, 2021. No protests were filed; therefore, this application is processed pursuant to the Commission's Rule of Modified Procedure.

O P I N I O N A N D F I N D I N G S

By virtue of the authority granted by the Commission in Docket No. C-1386, Applicant holds a certificate of authority as an interexchange carrier. Applicant also holds a certificate of authority as a local exchange carrier pursuant to Commission Docket No. C-3204. In this application, Applicant requests that its Certificates of Authority be withdrawn and their tariffs cancelled. Applicant has obtained the required approval from the Federal Communications Commission to discontinue its regulated services. Applicant has no remaining customers in Nebraska receiving regulated services, and the withdrawal of Applicant's Certificates will therefore not impact customers.

Upon consideration of the request and being fully advised in the premises, the Commission finds the request to be reasonable and finds that Applicant's Certificates of Public Convenience and Necessity to offer telecommunications services and all applicable tariffs should be cancelled.
