### OPINION AND FINDINGS

By Motion filed May 4, 2021 NE Colorado Cellular Inc., d/b/a Viaero Wireless (Viaero) requests an extension of time to complete the approved projects in the above-captioned application. On June 4, 2019 the Commission entered an Order approving NUSF support for two projects identified as the Reynolds site and the Swanton site. Viaero included a deployment schedule in its application and anticipated that the overall time for completion of the proposed projects would be approximately twenty-four (24) months.

In its Motion, Viaero states that due to the ongoing effects of the COVID-19 Pandemic, and market availability issues, Viaero has experienced unforeseen delays in obtaining the rebar necessary to complete the foundations for the approved projects. Viaero seeks a three-month extension of its deadline to complete the approved projects from the original estimated completion data of June 4, 2021 to September 4, 2021. Viaero will continue to monitor the progress of the approved projects and apprise the Commission of the status through regular status reports.

The Commission generally requires projects to be complete within two years of approval. However, the Commission has granted extensions of time for good cause shown. In this case, the Commission finds Viaero has worked diligently to complete these projects, but that circumstances outside of its control has led to the present delay. The Commission is of the opinion and finds the Motion for Extension of Time to Complete Proposed Projects should be granted. Accordingly, Viaero has until September 4, 2021 to complete the approved projects as requested.
