By application filed April 26, 2021, Hartington Telecommunications Co., Inc., Hartington, Nebraska, ("Hartington Telecommunications") seeks approval of a Wireless Traffic Exchange Agreement with New Cingular Wireless PCS, LLC, d/b/a AT&T Mobility, Dallas, Texas ("New Cingular"). Notice of the application was published in The Daily Record, Omaha, Nebraska, on April 30, 2021. No protests were filed; therefore, this application is processed pursuant to the Commission's Rule of Modified Procedure.

Pursuant to the federal Telecommunications Act of 1996 ("the Act"), specifically 47 U.S.C. § 252(a), Hartington Telecommunications and New Cingular entered into a Wireless Traffic Exchange Agreement arrived at through voluntary negotiations. An executed copy of this agreement is contained within the application.

Neither the agreement nor any portion thereof discriminates against any telecommunications carrier. Furthermore, the implementation of the agreement is consistent with the public interest, convenience, and necessity.

Section 252(e) of the Act requires this Commission to review agreements adopted by negotiation or arbitration to ensure they comply with Sections 251 and 252(d) of the Act, as well as all applicable state laws. Using those standards, the Commission finds that this Wireless Traffic Exchange Agreement should be approved.

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that the Wireless Traffic Exchange Agreement between Hartington Telecommunications Co., Inc., and New Cingular Wireless PCS, LLC, d/b/a AT&T Mobility, shall be, and is hereby, approved.
