## BY THE COMMISSION:

By application filed May 10, 2021, Qwest Corporation dba CenturyLink QC, Denver Colorado, ("CenturyLink") seeks approval of an FCC Modernizing Unbundling and Resale Requirements Amendment to its Interconnection Agreement with Nebraska Technology and Telecommunications, Inc., Omaha, Nebraska ("Nebraska Technology"). Notice of the application was published in <a href="The Daily Record">The Daily Record</a>, Omaha, Nebraska, on May 13, 2021. No protests were filed; therefore, this application is processed pursuant to the Commission's Rule of Modified Procedure.

Pursuant to Section 252(a) of the Telecommunications Act of 1996 (the Act), CenturyLink and Nebraska Technology entered into an amendment to their Interconnection Agreement arrived at through voluntary negotiations. An executed copy of this agreement was contained within the application.

Neither the amendment nor any portion thereof discriminates against any telecommunications carrier. Furthermore, the implementation of the amendment is consistent with the public interest, convenience and necessity.

Section 252(e) of the Act requires this Commission to review interconnection agreements adopted by negotiation or arbitration to ensure they comply with Sections 251 and 252(d) of the Act, as well as all applicable state laws. Using those standards, the amendment should be approved.
