BY THE COMMISSION:

On May 17, 2021, an Application was filed by Marsha Barr of Liberty, Nebraska, seeking authority to receive advanced telecommunications service from the North Summerfield Exchange of Blue Valley Telecommunications, Inc. ("Blue Valley"), in lieu of her current telephone service from Windstream Nebraska, Inc. ("Windstream"). Notice of the application was published in The Daily Record, Omaha, Nebraska, on May 19, 2021. No protests were filed; therefore, this docket was handled pursuant to the Commission's Rules of Modified Procedure.

O P I N I O N A N D F I N D I N G S

Blue Valley and Windstream are local exchange carriers holding certificates of public convenience and necessity to provide local exchange service in their respective territories. Marsha Barr is located within the boundary of Windstream's Liberty Exchange and has requested a boundary change so that she may receive telephone service from the North Summerfield Exchange of Blue Valley Telecommunications, Inc. Windstream has notified the Commission that it does not oppose the proposed boundary change. Blue Valley has also notified the Commission that it is willing to make the boundary change and provide service to the Applicant.

Changes of a local exchange territory are governed by Neb. Rev. Stat. §§ 86-135 to 86-138. Section 86-135 states that only upon non-consent of all telephone carriers involved shall the Commission hold a public hearing in the application. With no protest filed by any party and with each of the affected local exchange carriers consenting to the boundary change, the Commission processes this application administratively and without a public hearing.

The Commission staff has modified the Blue Valley and Windstream local exchange maps to show the boundary change to the Liberty Exchange and the North Summerfield Exchange. Copies of the

exchange maps with the proposed revisions are attached as Attachment "A" to this Order and hereby incorporated for reference. If either company has objections or changes to the proposed boundary map, it must contact the Commission before July 20, 2021 with said objections or changes. If the Commission receives no objections or changes from Blue Valley or Windstream by close of business on July 20, 2021, the boundary maps shall be modified as proposed in Attachment "A".

The Commission finds that, in light of the consent between the parties involved, the application is in the public interest and should be granted. It is the expectation of the Commission that the two carriers involved in the boundary change shall collaborate in good faith to ensure that the transition of the customer's service from one carrier to the other shall be as seamless as possible.

O R D E R

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Application No. C-5262 be, and it is hereby, granted.

IT IS FURTHER ORDERED that the revised exchange boundaries detailed in Attachment "A" to this Order shall be made the official boundaries of the North Summerfield Exchange of Blue Valley Telecommunications, Inc. and the Liberty Exchange of Windstream Nebraska, Inc. on July 21, 2021, provided no objection is received from either company prior to that date.
