By application filed June 1, 2021, Citizens Telecommunications Company of Nebraska d/b/a Frontier Communications of Nebraska, Mound, Minnesota, ("Citizens") seeks approval of an Amendment to their Interconnection Agreement with Onvoy, LLC, Chicago, Illinois ("Onvoy"). Notice of the application was published in The Daily Record, Omaha, Nebraska, on June 7, 2021. No protests were filed; therefore, this application is processed pursuant to the Commission's Rule of Modified Procedure.

Pursuant to Section 252(a) of the Telecommunications Act of 1996 (the Act), Citizens and Onvoy entered into an amendment to their Interconnection Agreement arrived at through voluntary negotiations. An executed copy of this agreement was contained within the application.
