By application filed June 2, 2021, Qwest Corporation dba CenturyLink QC, Denver Colorado, ("CenturyLink") seeks approval of an Unbundled Network Elements and Resale Forbearance Amendment to its Interconnection Agreement with MCImetro Access Transmission Services, LLC, Basking Ridge, New Jersey ("MCImetro"). Notice of the application was published in The Daily Record, Omaha, Nebraska, on June 4, 2021. No protests were filed; therefore, this application is processed pursuant to the Commission's Rule of Modified Procedure.

Pursuant to Section 252(a) of the Telecommunications Act of 1996 (the Act), CenturyLink and MCImetro entered into an amendment to their Interconnection Agreement arrived at through voluntary negotiations. An executed copy of this agreement was contained within the application.

Neither the amendment nor any portion thereof discriminates against any telecommunications carrier. Furthermore, the implementation of the amendment is consistent with the public interest, convenience and necessity.
