BY THE COMMISSION:

By application filed June 23, 2021, Qwest Corporation dba CenturyLink QC of Denver, Colorado ("CenturyLink") seeks approval of a Third Party Transit Provider Amendment to its Interconnection Agreement with Wide Voice, LLC of Las Vegas, Nevada ("Wide Voice"). Notice of the application was published in The Daily Record, Omaha, Nebraska, on June 25, 2021. No protests were filed; therefore, this application is processed pursuant to the Commission's Rule of Modified Procedure.

Pursuant to Section 252(a) of the Telecommunications Act of 1996 (the Act), CenturyLink and Wide Voice entered into an amendment to their Interconnection Agreement arrived at through voluntary negotiations. An executed copy of this agreement was contained within the application.

Neither the amendment nor any portion thereof discriminates against any telecommunications carrier. Furthermore, the implementation of the amendment is consistent with the public interest, convenience and necessity.

Section 252(e) of the Act requires this Commission to review interconnection agreements adopted by negotiation or arbitration to ensure they comply with Sections 251 and 252(d) of the Act, as well as all applicable state laws. Using those standards, the amendment should be approved.

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that the Third Party Transit Provider Amendment to the Interconnection Agreement between Qwest Corporation dba CenturyLink QC and Wide Voice, LLC, be, and is hereby, approved.
