On May 3, 2021, an application was filed by LTD Broadband LLC of Las Vegas, Nevada ("LTD Broadband" or "Applicant"), seeking Eligible Telecommunications Carrier designation in Nebraska. Notice of the application appeared in The Daily Record, Omaha, Nebraska, on May 7, 2021. A petition seeking informal intervention was filed by the Nebraska Rural Broadband Alliance ("NRBA") on June 8, 2021, and was granted by Hearing Officer Order on June 14, 2021.


