BY THE COMMISSION:

By notice filed November 22, 2021, and pursuant to Commission Docket No. C-2508, Custom Teleconnect, Inc. ("Custom Teleconnect" or "Applicant") of Las Vegas, Nevada, requests cancellation of its authority to operate as an interexchange carrier of telecommunications services and to cancel its tariff in the State of Nebraska. Notice of the application was published in The Daily Record, Omaha, Nebraska, on November 26, 2021. No protests or interventions were filed; therefore, this application is processed pursuant to the Commission's Rule of Modified Procedure.

## O P I N I O N     A N D     F I N D I N G S

By virtue of the authority granted by the Commission in Docket No. C-2508, Custom Teleconnect was given the ability to offer interexchange telecommunications service within the State of Nebraska. Custom now seeks cancellation of its Certificate of Public Convenience and Necessity and its Tariff within the State of Nebraska. The Applicant states that the Certificate is no longer necessary because it currently does not serve any customers.

Upon consideration of the request and being fully advised in the premises, the Commission finds the request to be reasonable and finds that Custom's Certificate of Public Convenience and Necessity to offer telecommunications service should be cancelled, along with all applicable tariffs.

## O R D E R

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Application No. C-5356 is hereby granted, and the Certificate of Public Convenience and Necessity granted to Custom Teleconnect Inc. of Las Vegas, Nevada to offer telecommunication
