On January 11, 2022, an application was filed by Matrix Telecom, LLC, d/b/a Trinsic Communications d/b/a VarTec Telecom d/b/a Excel Telecommunications d/b/a Impact Telecom d/b/a Startec d/b/a Lingo, Dallas, Texas ("Applicant"), seeking a name change to Lingo Telecom, LLC d/b/a Trinsic Communications d/b/a VarTec Telecom d/b/a Excel Telecommunications d/b/a Impact Telecom d/b/a Startec d/b/a Lingo. Notice of the application was published in The Daily Record, Omaha, Nebraska, on January 13, 2022. No protests were filed; therefore, this application is processed pursuant to the Commission's Rule of Modified Procedure.

O P I N I O N A N D F I N D I N G S

Applicant is authorized to provide interexchange telecommunications services in Nebraska. In the present application, Applicant requests that the Commission enter an order approving the name change to Lingo Telecom, LLC d/b/a Trinsic Communications d/b/a VarTec Telecom d/b/a Excel Telecommunications d/b/a Impact Telecom d/b/a Startec d/b/a Lingo. Applicant has received authority from the Secretary of State to use the new name, and submitted a sample customer notification of the name change with this Application. Based on the evidence adduced, the Commission is of the opinion the application is in the public interest and should be granted.
