### O P I N I O N        A N D        F I N D I N G S

The Commission initiates the above-captioned Progression Order to open a grant window for its wireless infrastructure grant program. The Commission last modified its criteria for this program in Progression Order No. 9, in an Order issued on November 5, 2019. Pursuant to the criteria set forth in that Order, the Commission hereby finds that the grant window for 2022 universal service fund support should be opened. The application window for the next round of grants will therefore open on March 1, 2022 and extend through April 15, 2022.

We find that the amount made available for the 2022 grant application cycle should be set at \$8 million. This amount includes additional funding due to previously unallocated cash reserves in the NUSF. This additional support is a one-time addition to the typical annual program allocation. The Commission will review the status of the NUSF budget in 2023 but, does not expect to be able to provide support for NUSF-92 projects at this level in future years.

Applicants must file an electronic copy of their application on or before 5:00 p.m. Central Time on April 15, 2022. The proposed budget and census block information should be filed in an Excel format. If the application contains confidential information, each applicant must also file one (1) complete copy, and one (1) redacted copy of the application.
