### O P I N I O N   A N D   F I N D I N G S

By application filed on January 31, 2022, University of Maryland Global Campus (Applicant), of Adelphi, Maryland, seeks authority to register the connection of an automatic dialing-announcing device located in Santa Clara, California.

Applicant is a state government entity and became an independent institution within the University System of Maryland in 1970, whose mailing address is 3501 University Boulevard East, Adelphi, Maryland 20738. Applicant proposes to connect a Five9 Software's automatic dialing-announcing device.

Having reviewed the matter, the Commission finds that the application complies with the applicable statutes and Rules and Regulations of the Commission regarding automatic dialing-announcing devices.

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that Application No. AD-705 be, and is hereby granted, and University of Maryland Global Campus be, and is hereby authorized to connect an automatic dialing-announcing device in accordance with its application, the Nebraska Statutes and the Rules and Regulations of this Commission.

IT IS FURTHER ORDERED that this order be, and it is hereby, made the Commission's official registration as set forth in this order and shall remain in force and effect for two years from this date unless used in a manner inconsistent with state or federal law.
