BY THE COMMISSION:

On March 30, 2022, an application was filed by Nebraska Holdings, LLC d/b/a OPTK Networks ("OPTK" or "Applicant"), seeking approval to secure \$18.8 million in debt financing. Notice of the application was published in The Daily Record, Omaha, Nebraska, on April 19, 2022. No protests were filed; therefore, this application is processed pursuant to the Commission's rule of modified procedure.

OPINION AND FINDINGS

OPTK is a privately held Nebraska limited liability company with its principal office located at 3900 NW 12th Street, Suite, 100, Lincoln, Nebraska 68521. Applicant holds certificates of public convenience and necessity to provide local exchange and interexchange telecommunications services in the State of Nebraska pursuant to approved Application Numbers C-4438 granted on March 6, 2012 ¹ and C-4748 granted on May 5, 2015.²

OPTK seeks to obtain debt financing in the amount of \$18.8 million to be used in connection with Applicant's business operations including: (a) to refinance Applicant's existing indebtedness, (b) to provide Applicant with working capital, (c) to provide capital for facilities construction to enlarge Applicant's fiber network, (d) to provide capital for general business purposes, and (e) to fund fees and expenses associated with the Loan.

Applicant has received and has accepted a commitment by Union Bank and Trust Company of Lincoln, Nebraska ("UBT") to enter into a Business Loan Agreement to provide Applicant with an \$18.8 million line of credit loan (the "Loan"). Applicant expects to secure the Loan through the provision to UBT of a first lien on substantially all of Applicant's assets, and as such, Applicant will pledge its assets to secure performance of the Loan. Any foreclosure of the security interest granted to UBT and exercise of remedies by UBT would be subject to customary conditions to obtain required transfer of control approvals from the Federal Communications Commission and this Commission. A summary of terms and conditions of the Loan was attached to the above captioned application as Confidential Attachment A.

Applicant seeks approval from the Commission pursuant to Neb. Rev. Stat. \S 75-148, which states, in pertinent part:

A common carrier may issue stock, bonds, notes, or other evidence of indebtedness, payable at periods of more than twelve months after the date thereof, when necessary for the acquisition of property, the construction, completion, extension, improvement of facilities, the improvement or maintenance of its service, or the discharge or lawful refunding of its obligations if the common carrier first secures from the Commission an order authorizing such issue and the amount thereof and stating that in the opinion of the Commission the use of the capital to be secured by the issue of such stock, bonds, notes, or other evidence of indebtedness is reasonably required for purposes of the carrier.

Upon review of the evidence, the Commission finds that the application filed herein is in compliance with the applicable Nebraska Statutes and that the debt financing agreement is reasonably required for the aforementioned purpose. The application is fair, reasonable, in the public interest, and should be granted.
