BY THE COMMISSION:

The Nebraska Public Service Commission ("Commission") initiated this proceeding on June 29, 2021, to establish reverse auction procedures and requirements in order to carry out Neb. Rev. Stat. § 86-330 (2018). On May 7, 2021, the Governor approved the Commission's Reverse Auction Rules and Regulations, which are now codified in 291 Neb. Admin. Code, Ch. 16. In an order dated June 28, 2022 ("June 28 Order"), the Commission entered an order setting forth the 2022 Reverse Auction ("Auction") budget, rules, and procedures.

In the June 28 Order, the Commission required that any applicant wishing to participate in the Auction submit a completed Pre-Auction Application Form prior to 5:00 p.m. on July 15, 2022. Complete Pre-Auction Applications were received from five bidders before the deadline. One applicant, AMG Technology Investment Group, LLC dba NextLink Internet, submitted a Pre-Auction Application Form after the deadline. This application was not accepted or reviewed. Additionally, one applicant, Resound Networks, was disqualified from participation in the Auction due to financial and technical concerns identified by staff.

Upon review of the Pre-Auction Application Forms submitted in this docket, the following bidders are hereby deemed qualified to participate in the 2022 Reverse Auction:
