BY THE COMMISSION:

The Nebraska Public Service Commission ("Commission") hereby initiates this proceeding on its own motion to administer federal Coronavirus Capital Projects Fund ("CPF") funding for broadband development in Nebraska pursuant to Neb. Rev. Stat. § 81-12,245 and in accordance with the Nebraska Broadband Bridge Act, Neb. Rev. Stat. §§ 86-1301 - 1312. Pursuant to statute, and in cooperation with the Department of Economic Development, the Commission will distribute CPF funding through the Nebraska Broadband Bridge Program ("NBBP") in grants for the purpose of facilitating and funding the development of broadband networks in unserved and underserved areas in Nebraska.

Pursuant to Neb. Rev. Stat. § 81-12,245, at least \$40 million must be allocated to broadband infrastructure projects located within Nebraska's first congressional district ("District 1"), and at least \$40 million must be allocated to broadband infrastructure projects located within Nebraska's third congressional district ("District 3"). Projects located within District 3 must be awarded to projects in cities of the second class and villages.²

CPF funding is required to be spent by December 31, 2026.³ Given that NBBP projects are given a minimum of eighteen months for completion, with extensions available, ⁴ the Commission intends

to complete all funding awards in CPF-funded NBBP cycles by December 31, 2024, at the latest. The Commission further intends to allot time to conduct at least two CPF-funded grant cycles in order to ensure that all available funding can be awarded. Because CPF-funded NBBP cycles do not require a project match from applicants, the Commission finds that CPF-funded NBBP cycles should not be conducted concurrently with state-funded NBBP cycles which do require a project match. Finally, the Commission recognizes the pressing need for broadband deployment funding in Nebraska and wishes to expedite the grant award process to the greatest extent possible.

For the above-listed reasons, the Commission finds that the first CPF-funded NBBP grant cycle should be conducted in the first half of the calendar year 2023. Application materials, including application forms and detailed instructions, will be made public on Tuesday, January 10, 2023. Applications will be due to the Commission on Friday, February 24, 2023. Grant awards will be issued on Tuesday, June 20, 2023. A complete procedural schedule is included with this order as Attachment A.

The Commission recognizes that the procedural schedule set forth below does not allow for a formal comment and hearing period. However, interested parties are encouraged to reach out to the Commission via psc.broadband@nebraska.gov with any relevant questions or input.

ORDER

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that the above-captioned docket be, and it is hereby, opened.

IT IS FURTHER ORDERED that the procedural schedule set forth in Attachment A to this order be hereby adopted, and the deadlines set forth within be adhered to.
