#### BY THE COMMISSION:

The Nebraska Public Service Commission ("Commission"), on its own motion, opened the above captioned dockets for the purpose of ensuring that recipients of funding for broadband, including regulated carriers and communications providers, as well as carriers receiving Nebraska Universal Service Fund ("NUSF") support, are in compliance with Executive Order No. 23-05 and subsequently codified Nebraska Revised Statutes.

On February 22, 2023, Governor Jim Pillen signed executive order No. 23-05<sup>1</sup> ("Executive Order") which prohibits the State from awarding any grant funding designated for broadband deployment in Nebraska to any provider using or deploying communications equipment and services developed by organizations on the FCC's Covered List.<sup>2</sup> The Nebraska Legislature subsequently codified Neb.

Rev. Stat. §§ 86-125 (4)(c) and 86-324 2(d) to require the Commission to ensure all communications providers in Nebraska are not using or deploying any communications equipment or service deemed to post a threat to national security identified on the Covered List, and required the Commission to withhold support distributed from the NUSF to any telecommunications company using or providing any communications equipment or service deemed to pose a threat to national security identified on the Covered List developed pursuant to 47 C.F.R. 1.50002.<sup>3</sup>

The Commission administers various programs within which state and federal funds for the deployment of broadband infrastructure are awarded. These programs include the Nebraska Broadband Bridge Program, federal Capital Projects Funds awards, and the Precision Agriculture Grant Program. Grant awardees in these programs must attest that they will not use equipment on the Covered List before funds are distributed. As such, the Commission finds that it should maintain information regarding the use of prohibited equipment by entities certificated in Nebraska.

### OPINION AND FINDINGS

On March 28, 2023, in order to comply with Governor Pillen's Executive Order, the Commission opened Docket No. C-5493/PI-245 to require certificated local exchange carriers, interexchange carriers, and eligible telecommunications carriers in Nebraska to attest as to whether they are using or deploying communications equipment prohibited by the FCC. After the Commission completed its collection of attestations from carriers subject to the docket, it published and continues to update the list of carriers ineligible from being awarded State broadband funding. In order to comply with Neb. Rev. Stat. §§ 86-125 (4)(c) and 86-324 2(d), the Commission opened Docket No. C-5520/PI-246, to expand the scope of entities included in its original data collection to include communications providers registered in Nebraska that had not previously filed an attestation with the Commission in the C-5493/PI-245 docket.

In order to promote administrative efficiency, the Commission finds that Docket Nos. C-5493/PI-245 and C-5520/PI-246 shall be combined and its obligations and findings shall be incorporated

into one consolidated docket.<sup>4</sup> As such, a consolidated list of regulated carriers and communications providers using or deploying communications equipment and services developed by organizations on the FCC's Covered List is attached to this order as 'Attachment A.' The Commission finds that 'Attachment A' shall be the official list of all local exchange carriers, interexchange carriers, eligible telecommunications carriers, and communications providers ineligible from receiving NUSF and/or State broadband funding.

Moreover, the Commission finds that all local exchange carriers, interexchange carriers, eligible telecommunications carriers, and communications providers certificated or registered in Nebraska shall be required to provide to the Commission an attestation as to whether they are using or deploying prohibited equipment. The Commission finds that this attestation should be included with the forms required to be completed as part of the annual report process and submitted before April 30 of each calendar year.

Grant programs affected by this requirement include, but are not limited to, the Nebraska Broadband Bridge Program, federal Capital Projects Funds awards, and the Precision Agriculture Grant Program. Specific requirements for each program will be detailed within the Commission docket relevant to that program.

Finally, the Commission finds that those entities who fail to file this attestation will be presumed to use or rely on prohibited equipment and will be ineligible from receiving NUSF and/or State funding designated for broadband deployment. All current ineligible carriers are listed in 'Attachment A' to this order. The Commission will publish this list on its website and will update it periodically as new carriers are added and as carriers come into compliance.

ORDER

IT IS THEREFORE ORDERED by the Nebraska Public Service Commission that all local exchange carriers, interexchange carriers, eligible telecommunications carriers, and communications providers certificated or registered in Nebraska shall be required to file the above-described information with the Commission on or before April 30, 2024, and annually thereafter, as prescribed herein.

IT IS FURTHER ORDERED that all carriers listed on 'Attachment  $A^{\prime}$  or on any updated version published on the Commission website henceforth shall be ineligible from being awarded State broadband funding.
